Dear friends and co-workers!

Humanity stands today between two lines of force. One is characterised by a brutal, materialistic-oriented attitude that seeks to make profit out of all beings and circumstances throughout the world. The other is characterised by those who see it as their highest value to live according to universal and eternal values and ethics. In between, there are millions of people who have to struggle to survive and to try to preserve their rights as human beings as laid down in the Universal Declaration on Human Rights and the United Nations Charter.

The political structure of the world of today was established by a generation who divided the world into different national states, organised institutional religions and fed a strong sense of competition between the industries of the different countries. Today, the division does not seem to run any longer between different States but between a small minority that takes decisions in its own interest, regardless of the cost to humans and nature, and those who see the need for decisions that are in the interest of all, humans and nature.

In order to ensure a prosperous existence not only for ourselves but also for future generations, a new attitude is required, based on an inner code of conduct characterised by active goodwill, inclusiveness and respect for all life. Respect for all life is the attitude which will help us achieve global good governance and overcome illusion, glamour and misunderstanding.

We live today in a world imposed on humanity by people with narrow-minded national and religious interests. Those who have developed a global view but who remain attached to their personal interests exploit these divisions to continue to divide and weaken us. Our national States and institutional religions are like straightjackets that prevent us from establishing constructive cooperation beyond and above all borders and barriers of nationality, race or religion. If we all work together as human beings, we

will create a new world civilisation and world culture of mutual respect in which the resources of the different countries will not be controlled by national governments and international corporations. We will work together and exchange the natural resources and the products of our labour for the betterment of all. A global awareness based on universal values and eternal ethics will form the basis of a global attitude of respect for life and will lead us to produce only what is useful for the physical, mental, social and spiritual health and evolution of all living creatures on our planet.

Individual responsibility and pure motivation are necessary to develop a mental matrix for building a world based on healing cleavages and misunderstandings between nations, cultures and institutional religions. The first step towards this new world is love of truth. If we realise the importance of seeking and loving truth in all circumstances, towards ourselves and others, and abandon our fears to lose face, to acknowledge our mistakes to ourselves and whenever necessary also to others, we will start to develop insight in two directions simultaneously. We will gain insight into the background of events around us, and we will develop a deeper understanding of life itself within us.

Insight into and true understanding of individual and world concerns is urgently needed for us to come out of the present world crisis and the thousands of concomitant problems which we keep creating all the time because of our inability to abandon our old patterns of behaviour that lead us to repeat again and again always the same mistakes.

Insight demands a certain discipline of quietness and silence for it to open us to new aspects of life and planetary evolution. Especially today, insight into the human kingdom prepares us for a shift from national to global awareness, for an understanding of humanity as a global family.

Insight could be defined as the art of "seeing into". For example the cultivation of contemplation and reflection upon events and circumstances leads us up into the realm of mental functioning, moves us out of the purely emotional or astral reaction to "effects" and into the thought processes of asking **why** is this happening? Why did this happen (again)? In other words, we train ourselves to look into (in-sight) events and by so doing train ourselves to pay attention to causes on all levels of human activity.

Insight is also the readiness to observe, recognise and face one's own weak points in the light of a healthy common sense and of one's own conscience, and then to take the steps that are necessary to overcome them. What we improve in ourselves of our own free will, applying goodwill and love of truth, reverberates in our environment through our example, adding to the sum total of spiritual awareness in the world.

Urusvati knows that hypocrisy is based on heartlessness. Indeed, the bond with the higher spheres is formed through the heart, a heart generous in all its expressions. It is impossible to imagine a strong state consisting of hypocrites and swindlers. Hypocrisy is incompatible with the highest beliefs and knowledge, and a false foundation will serve only a false structure. We do not approve of the slightest manifestation of hypocrisy, and believe that this vice begets all other corrupt feelings. (Supermundane I, §244)

and using the mentality to live and work. One no longer feels a helpless victim of circumstances because insight helps one to see **why** such and such happened and therefore we can take measures to avoid a "repetition" and also to predict how certain situations may evolve.

Thus **insight** is a most valuable tool for each one of us, individually, and even more so in group work and relations, in world service, in meeting human need and being insightful about what that need is and how best to meet it, and ultimately for humanity as a whole.

"Ultimately, the final decisions in world affairs have to be made through mankind's deliberate choice... In a unique manner, men are today facing a period of the freeing of the human soul, or a period of its imprisonment indefinitely; the right decision will lead to the Kingdom of God, and the other to a retrogression which will defy the past and prolong past wrong action..." Held shortly after the beginning of the Irak invasion, this roundtable addressed a number of questions related to humanitarian law and war. The multiplication of armed conflicts in the world places a heavy burden on humanitarian organizations. The warring parties often fail to respect humanitarian law, especially as embodied in the Geneva Conventions. Humanitarian aid is withheld or hijacked by the military in order to gain military advantage. Nevertheless, as expressed by Mr. Michel, the fact that people contravene the law does not mean that the law should be abolished. Otherwise, we would also have to abolish traffic laws. Henry Dunant saw the importance of considering every soldier first of all as a human being, and not as an enemy. This is the universal basis of all ethics and all laws, and is eternally valid.

Israel does not recognize the right to conscientious objection, which is derived from Article 18 of the International Covenant on Civil and Political Rights, of which Israel is a signatory. In Israel, conscientious objectors risk prison and court martial.

D E C I S I O N OF THE FIRST INTERNATIONAL CONGRESS «GENOFUND–3000»

The First International Congress “Genofund 3000” took place in Odessa, Ukraine, from 12-16 April. It was attended by 126 participants from 5 countries (Ukraine, Russia, Switzerland, Germany, Belarus). Among the participants were representatives of State and public organizations, the United Nations and other international organizations.

The Congress considered the following subjects:

1. **Genofund of the Planet** as a uniform system. **The quality of the genofund** of the country as a basic resource and integral index of the social development of the country.
2. **The role of public and national structures, Scientific and business circles** in forming the regional health and longevity managing systems, retaining and improving genofund quality.
3. **Political, social and psychological climate of the society and territory** as a resource for maintaining and improving the genofund, moral and genetic health. **System indices of health** of a human being, family, society and human civilization.
4. **Stress** as a genofund-destroying factor. **Stress resistance** as the basis for the moral, psychological, social and genetic health of people and society. **Fear and stress**. Main fears and their sources (starvation, diseases, terrorism, etc.). Models and methods for overcoming fear.
5. **Drugh epidemic, alcoholism, AIDS, rising aggressiveness, criminality and other social and moral diseases** as blows against the genofund. Regional prophylactic systems and models of rehabilitation of socially disadvantaged persons.
6. **Health management** as a resource for preserving the genofund and national safety. **Educational medicine and information** as a means for preserving and strengthening the genofund. **Dietary culture** as a means for preserving the genofund of society and national food security.
7. **Health and longevity** as the required and guaranteed result of education and training: new models and technologies of public and social education.
8. **Education** as an effective method for developing and implementing system-wide social programs to promote a healthy way of life of individuals and society.
9. **Children and youth** as the main driving force of renovation and restoration of genofund. **System-wide models of interactions between children, parents, school, family and the State** as the basis for preserving and improving the genofund.

The Congress noted and stated:

1. The changes in the international situation connected with the latest events in Iraq have shown that the consciousness of the world community no longer accepts force as a way to solve problems. The Congress participants therefore see new possibilities of international cooperation to create a world without wars and conflicts by implementing system-wide public education projects in order to enhance the physical, social and moral health of society within the framework of the International Project “Planet 3000”.
2. The Congress participants decided to call the project: International Mega Project “Genofund 3000”.
3. The Mega project “Genofund 3000” integrates working projects in the regions, makes known the results of our efforts and enables us to enter a new level of concerted actions for creating a new standard of life, health and longevity as the basis for the development of the socially-oriented State.
4. During the Congress the project for implementing the Mega Project “Genofund 3000” was developed. The project includes various programs and the following working groups:
 - “From healthy teachers to healthy generations”
 - “Psychological climate of the school as the basis for the humanization of society”
 - “I choose life” – rehabilitation of incurable and chemically dependent patients
 - “From healthy families to healthy nations”
 - “Treatment by creativity”
 - “From harmonious relations to a harmonious life”
 - “From social defense to social creativity”
 - “The world of the aged persons”
 - “Culture, art, mass media, sport, tourism – for health and longevity”
 - “Social creativity of children and youth as a resource for the revival of th genofund”
 - “From public education to a socially-oriented society” – a project for the regional development of public education

The Congress decided:

1. To hold the Congress "Genofund 3000" annually in Odessa.
2. To adopt the agreed International Mega Project "Genofund 3000" with international headquarters in Odessa, Ukraine.
3. To approve four projects as part of "Genofund 3000":
 - "From public education to a socially-oriented State"
 - "From harmonious families to harmonious societies"
 - "From social diseases to a culture of health"
 - "Culture, art, information, tourism"
4. To adopt the following main documents:
 - Memorandum on Iraq events
 - Decision of the First Congress "Genofund 3000"
 - Letter thanking the UN, UNESCO, State structures of countries and cities which sent participants to the Congress, and offering permanent cooperation
 - Schedule of agreed events and programs for carrying out the Mega Project "Genofund 3000".
5. To designate the following persons to the International Committee of the Mega Project "Genofund 3000":
